- All personal watercraft (PWC) must be properly permitted with either an annual boat permit or a daily boat permit.
- Permits must be visible in the front windshield of the vehicle pulling the trailer.
- Annual permit stickers must be affixed to the starboard side up front by the State of Oklahoma ID Sticker.
- > PWC direction is always counterclockwise in the ski zone, boat, and PWC-approved areas.
- No skiing, tubing, or **PWC** use is allowed west of the buoy line where underwater trees are prevalent.
- ➤ PWCs must always have the following safety features on board:
 - o One wearable USCG-approved personal floatation device for each person on board.
 - If the PWC is equipped with a lanyard-type engine cut-off switch the lanyard must be attached to the person, clothing, or PFD of the operator always while the PWC is being operated.
 - o PFD must be in good serviceable condition. They must also be readily available.
 - o PWC navigated between sunset and sunrise must have all the required navigation lights.
 - PWC must always be navigated in a prudent manner. It is illegal to operate in a reckless manner. Examples: Too fast in a no-wake zone, operating within 150' of any boat ramp, any dock or pier, or anchored or moored vessel. Operating within 50' of any moving vessel. Weaving through congested traffic and playing chicken.
- No watercraft shall be left unattended. Unattended watercraft may be impounded for safekeeping and eventual disposition. All expenses will be the responsibility of the owner.
- > PWCs can only be tied off to the shoreline of the site you are renting.
- Courtesy docks are provided for the loading and unloading of Boat/PWC passengers. Sunbathing, swimming, and fishing from the courtesy docks are prohibited. Mooring on the courtesy docks is prohibited.
- A full list of the State Boating and PWC Laws and Responsibilities is available at the LCB Park Office. These rules must always be obeyed.
- Annual Tenants of LCB that choose to store their PWCs at LCB in approved areas are responsible for the mowing and weed eating under the trailer. Failure to keep the area mowed and trimmed under the Trailer will result in a fee to the tenant assessed onto their Bursar Account of \$100.00 per instance. Same fee as a non-mowed site.
